Membership Application and Renewal Form 2012

I / We the undersigned wish to apply for Friend of M.E.C. / Membership / Renewal of Membership of The M.otor Enthusiast's Club Ltd., and hereby agree to abide by the Rules and Bye-laws of The Company if elected / re-elected by the Board of Directors at the next Board Meeting, in accordance with paragraphs 2 to 6 of the Articles of Association of The Company which are printed below.

Articles 2 to 6, as set out in the Articles of Association of The Motor Enthusiasts' Club, Limited.

2. Application for Membership. Application for membership shall be in a format decided by the Directors and from time to time may be amended by them and unless otherwise stipulated, the payment of a subscription by the incoming member shall be a pre-requisite of membership. Where "Family Membership" has been applied for and granted, the persons admitted to membership under such application, shall be deemed to constitute one single member for the purposes of voting and determining a quorum.

3. Termination of Membership. If any member shall be in arrear with his subscription or any other money which may be due from him to the Club for three months after same shall become due, he shall cease to be a member of the Club.

4. If any member of the club shall wilfully disobey or fail to observe the provisions of the Memorandum or Articles of Association or By-laws for the time being in force, or shall conduct himself, whether as a member of the Club or otherwise, in such manner as is likely to bring discredit to the Club or cause his presence at the Club to be offensive to other members, the Directors shall be at liberty to expel such member and terminate his membership, provided they have given him ten days' notice of their intention to do so and also an opportunity to meet the charges made against him and to explain his conduct. Members shall similarly be liable to suspension.

5. The annual subscription shall be an amount as fixed by the Board from time to time. The annual subscription shall be due on the 1st January each year. Members shall not be entitled to any of the advantages of membership until the subscription for the current year is paid. The Board may grant temporary membership for periods of less than a year at reduced fees.

6. The Board may with the sanction of the Company in general meeting require payment of an entrance fee by applications for membership,
