#### I declare that:

1) I have been given the opportunity to read the General Regulations of Motorsport Ireland ('General Regulations') and, if any, the Supplementary Regulations for this Event and agree to be bound by them. I acknowledge the potential risks inherent with motor sport and accept that these risks may give rise to my suffering personal injury or other loss.

I understand that a breach of my obligations within this document may lead to being disqualified from the Event and heavy additional penalties.

To the best of my belief the driver(s) possess(es) the standard of competence necessary for the Event to which this entry relates and that the vehicle entered conforms to the Regulations of the Event. Where applicable the use of the vehicle hereby entered will be covered by insurance as required by law.

I agree that should I at the time of this Event be suffering from any disability whether permanent or temporary which is likely to affect prejudicially my normal control of the vehicle, I may not take part unless I have declared such disability to Motorsport Ireland which has, following such declaration, issued a licence which permits me to do so. I undertake that at the time of the Event to which this entry relates I shall have passed or am exempt from an ASN specified medical examination within the specified period.

If I am the Parent/Guardian/Guarantor of the driver I have countersigned the competitor licence application and understand that I shall have the right to be present during any procedure being carried out under the Event Supplementary Regulations and the General Regulations and that I have acquainted myself and the minor with them, agree to pay any appropriate charges and fees pursuant to those Regulations and agree to be bound by and submit myself without reserve to the consequences resulting from them (and any alteration thereof). Further, I agree to pay any liquidated damages any fines imposed upon me up to the maxima set out in the event guidelines.

I have read and shall respect the regulations for Control of Drugs and Alcohol as contained in the General rules and regulations and have also fully familiarised myself with the information on the web sites referred to ([www.motorsportireland.com](http://www.motorsportireland.com) and [www.wada-ama.org](http://www.wada-ama.org)) in particular the Sport Ireland Anti-Doping Rules which have been adopted by Motorsport Ireland. Further, if I am counter signing as the parent or Guardian of a minor then in addition to the deemed consent to the testing of that minor. I hereby confirm that I give such consent for the minor concerned to be so tested.

I understand and agree that my personal data is being processed solely for the purposes of running this Event and may be used for the purposes of COVID-19 infection tracing, and will be handled by the organisers in accordance with Motorsport Ireland data protection policy: [www.motorsportireland.com/data-protection](http://www.motorsportireland.com/data-protection).

I confirm I will bring all required documentation, licences etc., to the Event as usual and I understand that spot checks will be made with regard to documentation and technical checks.

#### **RISK WARNING, DISCLAIMER, AND INDEMNITY**

I understand that Motor Sport is a dangerous recreational activity and there is at all times a significant risk of injury, disability or death. I acknowledge that the risks associated with attending or participating in Motor Sport include but are NOT LIMITED to the risk that I may suffer harm as a result of motor vehicles (or parts of them) colliding with other motor vehicles or persons or property; other participants acting dangerously or with lack of skills; high levels of noise exposure; acts of violence and other harmful acts (whether intentionally or inadvertently) committed by persons attending or participating in the event; and the failure or unsuitability of facilities to ensure my safety.
